Mentoring - In 2022 M.U.S.T. served 29 high school aged Black male Mentees and 15, 18-25 year old Black male Mentors by providing weekly one on one mentoring sessions, bi-weekly outings that focused on self-development and college and career exploration, and quarterly life-skills events during school year months. Summer months engaged participants in self-development and social emotional enrichmentactivities bi-weekly. Monthly tracking showed 87% of M.U.S.T.s Mentees achieved one or more of M.U.S.T.s target outcomes for Mentees: better attendance in school, improved grades, elevated mental and emotional states, more developed ideas of their future plans, a deeper understanding of, and interest in college and career paths, and better family and community relationships. Of the 15 Mentors,all were employed with many applying to or currently enrolled in college.
